Applications accepted through May 1, 2022

Thank you for your interest in applying for a transportation grant from Cowiche Canyon Conservancy (CCC). These funds are to underwrite school district costs for educational field trips to CCC lands. Your field trip must be scheduled with CCC and approved prior to application for transportation funds.

Applicants must submit the following information for each requested grant:

- Complete application packet
- A letter of financial need including your plans for integrating your pre and post Trail Talks experience in the classroom curriculum following state standards

Applications will be evaluated on the following criteria:

- Completed application
- Narrative letter of financial need
- Brief description of your pre and post field trip activities related to your grade's state standards
- Date of application receipt

Applicants will be notified of their award status within 30 days of complete grant packet submission.

*Please note: Grant recipients are responsible for scheduling their own transportation.*

- Grants have a maximum value of \$300 per application and award.
- You must apply for each approved and scheduled field trip separately.

*Prerequisite for applying for the Transportation Grant:*

- You must have your Field Trip approved by your district and scheduled with CCC.

- Complete and submit all required information. Applications must be complete and legible. Please PRINT or use a word processor.
- Incomplete application will be returned.
- Grant recipients are responsible for arranging transportation and submitting grant payment requests (maximum of \$300) within 30 days of completing their Field Trip.
